**Supplementary Sailing Instructions**

**1. Rules**

- 1.1. The event will be governed by the Racing Rules of Sailing.
- 1.2. RMYS Sailing Instructions V6.0, the Agar Wynne Supplementary Sailing Instructions, the AMS rating system, the IRC rules parts 1, 2 and 3, the Yachting Victoria handicap system and the requirements of the Port of Melbourne Corporation (PoMC) will apply.
- 1.3. AS Special regulations part 1, sections 1-6, Safety Category 6 for racing boats will apply..

**2. Advertising**

Boats may be required to display advertising chosen and supplied by the organising authority.

**3. Notices to Competitors**

Notices to competitors will be posted on the RMYS <https://www.rmyns.com.au/sailing/racing/notice-of-race/>. They may also be posted on the RMYS official notice board. Registered boat owners may be notified by email or SMS.

**4. Changes to Sailing Instructions**

Registered boat owners may be notified by email or SMS by 0900 on the 23 January 2020. They may also be posted on the RMYS official notice board and the RMYS website.

**5. Signals Made Ashore**

Signals will be displayed from the flagpole of RMYS located on the main building.

## 9. Radio Communication

- 9.1. A pre-race sign on procedure will be conducted in accordance with the following procedure:
- 9.2. In addition to the mandatory Crew Declaration the HBYC Race Committee shall call each boat in alphabetical order on the designated radio channel approx. one hour prior to start VHF 69. The Race Start Committee may protest boat's failing to respond to compulsory sign on. When called, boats shall respond with boat name and number of persons on board. A listening watch will be kept on VHF channel 69 on *William Patterson*
- 9.3. Once on the eastern side of the channel on return leg contact *RMYS Tower VHF 69* and report ETA. (tower will be manned from 1600)
- 9.4. Except during the pre-race sign on procedure or in an emergency, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communication not available to all boats.

## 10. The Start

- 10.1. The start will be conducted in accordance with RRS 26. The start boat will be Privateer.
- 10.2. The starting line will be in the Vicinity of Ch Mark 71 or west of Ch Mark 76

## 11. The Course – Agar Wynne

- 11.1 Start

Committee Boat William Patterson (s) in approx. position 100m NW from Portarlington Pier

## **12 The Finish**

12.1 The finish line is as per the RMYS Sailing Instructions V6.0, Breakwater Finish.

12.2 Skippers are requested to make a note of their finish time.

## **13 Time Limit**

The time limit is 2015hrs on Saturday January 2021.

## **14 Crew Declaration and Intention to race**

- a. All competitors must do a crew sign on either via the member Point app or <http://tymob.net.au/1335> no latter that 0830 23 January 2021
- b. If also entering the HBYC race a separate crew declaration must be completed electronically via the following link - <http://tymob.net.au/1247>

## **15 Retirement**

Boats retiring shall contact RMYS Committee boat William Patterson on 69, or by other means, and report the circumstances of their failure to finish.

## **16 Protests and Requests for redress**

Protests and request for redress shall be lodged in accordance with the RMYS Sailing Instructions V 6.0.

## **17 Disclaimer of Liability**

Competitors participate in the race entirely at their own risk. See rule 4, Decision to Race: *"The responsibility for a boat's decision to participate or to continue racing is hers alone."* The Organising Authority will not accept any liability for material damage, personal injury or death sustained in conjunction with, prior to, during or after the races.

## **18 Insurance**

Each participating yacht shall be insured with valid third-party liability insurance with a minimum cover of AUD 10 million or the equivalent.
